Fixing system by means of multiperforated support for hollow partition of blue color for distribution and for IT multiperforated support for hollow partition of black color. 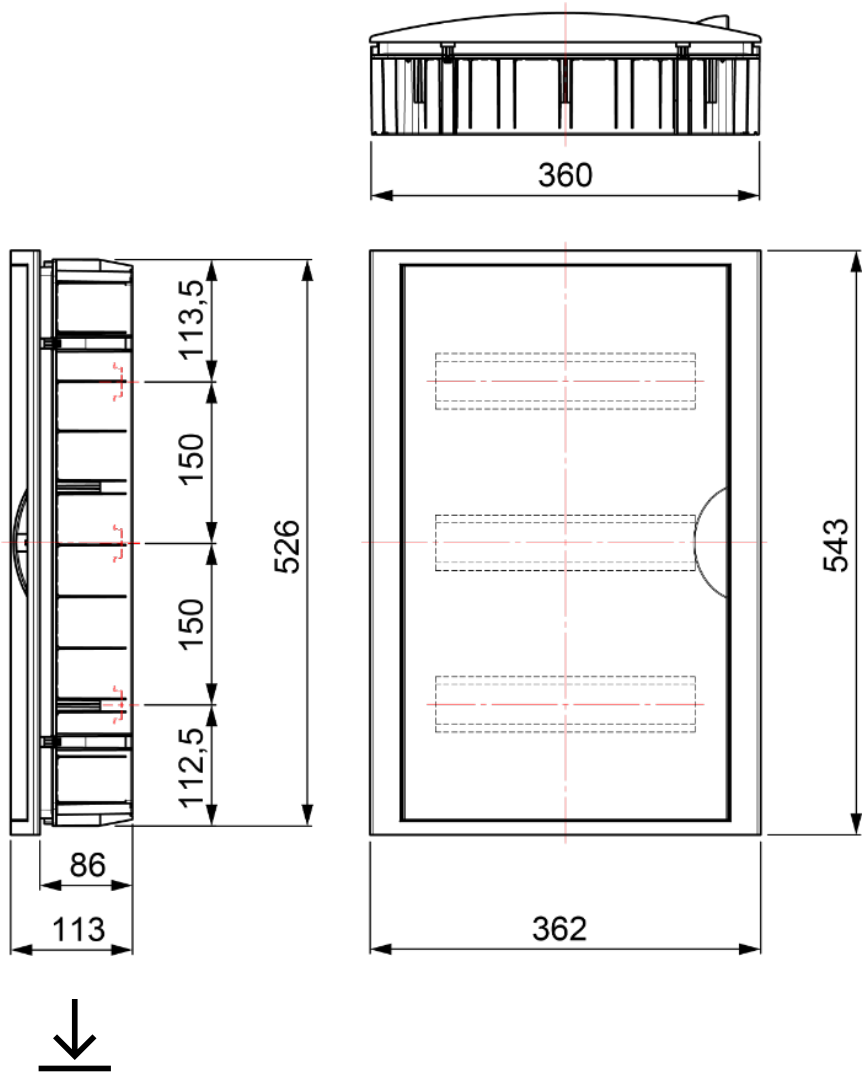

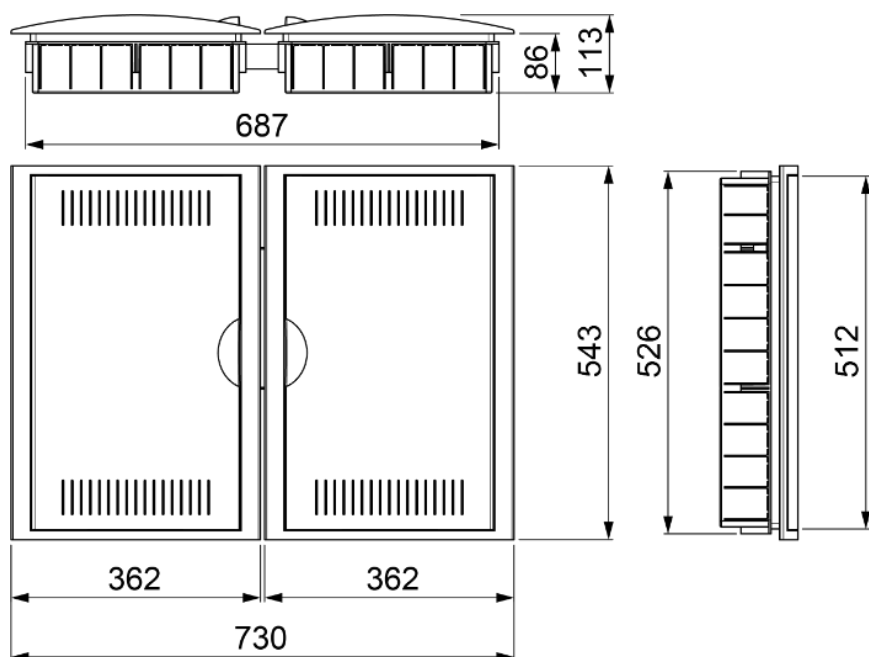
